Business:

- A question was asked about masking due to Covid cases and the increase in Covid numbers. Some hospitals are requiring masking again. Susan Barnhart reminded the Board that the Library follows the guidelines provided by Otsego County and as of this meeting no changes are necessary.
- A 12-month CD for \$40,000 was opened at NBT on January 11th, 2024 by Board President David Lapointe and Clerk Treasurer Kelly Jones. The interest rate is 4.25%.
- Discussion ensued regarding opening a money market account at NBT. Right now NBT is offering a rate of 3%. Board members agreed to invest \$27,000 that is currently in the NBT Checking Account into a money market account. The account should be opened for the Unadilla Public Library using the library's tax ID number. The account should have (two) authorized signers – Clerk Treasurer Kelly Jones and Board President David Lapointe. Board all agreed.
- Library Trustees went into executive session to discuss personnel matters. Rates for library personnel were set. Evaluations and self-evaluations were requested.

Director's Report:

- Irene has checked with Frontier Yellow Pages about having the library listed in the Yellow Pages. Was given a direct number to reach out to somebody about this.
- Revenues received for December 2023 were \$46. Prints \$1.00, Book Sales \$16.00, Donations \$1.00, Fundraising \$10.00, Lost Book Fee \$18.00.
- Received a donation from the Tianaderrah Foundation for \$3,000.
- December 2023 hours: Irene 63, Marc 43.5 (with 12 vacation).
- Irene has booked a program with Didgeridoo Down Under for Thursday, July 25th, 2024. The cost will be \$425.
