- A new story was placed on the storywalk. Nine new stakes for the Storywalk posts will be ordered for next year, to repair some of the old ones.
- Kelly Jones, Treasurer let Irene know the \$12.48 discrepancy was a credit from Amazon. NBT bank reversed a fee that was credited back to the library.
